

Beyond the Illusion: A Critical Examination of Howard Zinn's Perspective on American Democracy

In Zinn's provocative essay, "How Democratic is America", he ponders the reality of democracy in the U.S. and invites his audience to think beyond the constitutional and electoral pageantry. Zinn claims that although America appears to be a democratic state with elections, freedom of speech, and constitutional provisions, it does not effectively function as one.
